# **CONCLUSION OF INVESTIGATION NOTIFICATION**

**Involved Agency:** Saanich PD **Agency File No.:** 2022-5587 **IIO File No.:** 2022-105 Primary Investigator: Jacqueline BRETON **BRIEF BACKGROUND:** A female requested assistance with her adult son due to him suffering a mental health crisis. Officers attended and apprehended under MHA. He was taken to hospital and several days later was found to be suffering from a fractured collar bone. **BRIEF SUMMARY OF IIO INVESTIGATION:** A full investigation was completed and reviewed by the CCD, who has determined that no officer committed any offence in relation to the incident. The CCD notes that officers actions in attempting to de-escalate and manage the situation were of a high standard and will be commented upon publicly within our reporting on the matter. A public report will be released in due course.
