# 6.1 Six Month Initiative Progress Report

Chief Duthie has met with every section since taking on the Chief's role. Personnel have been informed of upcoming structured formal updates to provide everyone a perspective on what's occurring outside their Division. Chief Duthie provided additional updates for each Division.

# Patrol Division:

- Complimentary emails received from the community regarding the service response to Regina Park.
- Community Safety Officer (CSO) program was launched, filled by four strong officers.
- Tactical Support Team (TST) created by GVERT members.
- Patrol area refresh project is almost complete.

# Administration Division:

- Animal Control was transferred to the District in June,
- Perimeter security fence project is almost complete,
- Zero emission vehicles are being acquired for the fleet. Recruiting has a Mach-E,
- Expansion of women's change room.

#### Detective:

- Integrated Internet Child Exploitation (ICE) team was formed earlier in 2022, with members from Central Saanich, Saanich, VicPD.
- Special Investigations Section (child and adult sexual assault investigations) beginning in fall 2022,
- Detective Division moving to Cadillac in 2023.

#### **Professional Standards Office:**

- New audit plan will be introduced,
- Working on disaster preparedness plan,
- Policy manual is now located on SharePoint.

# **Community Engagement:**

- E-bikes acquired for Bikes Section,
- Community Safety office at Uptown opened spring 2022,
- Recruiting is complete for the Reserve class in fall,
- Community Engagement moving to HQ in 2023

#### Staff Development:

- New exempt police officer Cst. Adrien Se-Ung was sworn in today. Board members expressed appreciation for swearing-in ceremony.
- Work on 2023 transfers complete,
- Active Bystander for Law Enforcement (ABLE) training in fall,
- Recruiting, Equity, Diversity, and Inclusion (REDI) committee has secured 4-hour training sessions in 2023,
- Recruiting working on hiring for January 2023 class,
- Last member injured in BMO shooting will be released tomorrow.
