#### 1. TERRITORIAL ACKNOWLEDGEMENT

Ms. Beckett read the prepared Territorial Acknowledgment.

#### 2. PRESENTATION BY MOBILE YOUTH SERVICES TEAM (MYST)

Re: Impacts of Losing Police Liaison Officers in Schools

Ms. Mia Golden and Constable Gord Magee outlined the work of MYST over the past decade, highlighting a notable change since the removal of School Liaison Officers (SLOs). They discussed the increased presence of gangs, which has now extended to middle schools, and the void left by the absence of SLOs, resulting in MYST being called for issues previously handled by SLOs. They emphasized the crucial role SLOs played in dispelling misinformation, prevention, and supporting youth, noting that some young people believe their presence could have prevented gang recruitment. They advocated for the reinstatement of SLOs in schools to counter harmful messaging and assist youth.

The Board expressed appreciation for their presentation and acknowledged the importance of their work with youth.

The rationale behind creating this position is to allow CAPG to benefit from the years of experience and knowledge police governors take with them when their terms expire.

It is up to you to propose nominees who will bring the necessary competencies, including diversity, inclusivity, education and experience and most importantly a commitment to the success of the CAPG board and organization.
